Dear Gary:

This will confirm the Agreement between Irvin Feld and Kenneth Feld Productions, Inc. dba Ringling Bros. and Barnum & Bailey Circus ("Ringling Bros.") and you regarding the sale of one (1) elephant with the house name "Smokey" by Ringling Bros. to you. Our agreement is as follows:

1. Ringling Bros. owns a male Asian elephant born in the United States on February 3, 1984 named Smokey. You have seen and handled Smokey, and you wish to purchase Smokey from Ringling Bros.
2. Ringling Bros. agrees to sell Smokey to you for the sum of Fifteen Thousand Dollars (\$15,000.00) which shall be payable by you to Ringling Bros. in accordance with the following payment schedule set forth below:

\$5,000.00	due on	September 1, 1993
\$5,000.00	due on	June 1, 1994
\$5,000.00	due on	December 1, 1994
3. You agree, as additional consideration for the purchase of Smokey, to waive any and all claims for past services or property which you may have against Ringling Bros. or its related and affiliated companies in connection with any matter relating to Ringling Bros. animals, including, but not limited to, any ownership interests in any Ringling Bros. elephants.
4. You acknowledge that the transfer of ownership of Smokey to you gives rise to no liability on the part of Ringling Bros. now or in the future for any activity involving Smokey. Such

ownership shall take effect on the date on which this Agreement is signed by both parties.


5. Both parties acknowledge that the sale of Smokey is occurring intrastate within the State of Florida and, therefore, no federal permit is required for this transaction. Both parties hold valid and current Florida Fish and Game permits: Ringling Bros. and Barnum & Bailey, Class I, No. EPB 4323, expiration July 20, 1993; Gary Jacobson, Class I, No. EPA 1148, expiration July, 1993.

This Agreement contains the entire understanding between the parties and may not be amended except by an instrument in writing signed by both parties.
