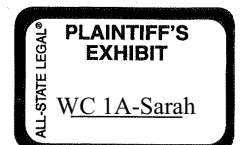
I discussed this in a second conversation with Deanna.

**Assessment:** NBA on feet. Vulvar blister either due to insect bite or elephant climbing on concrete barrier.

**Plan:** soak and trim nails as needed. For vulvar blister, monitor only.
